## I. General Information

## III. The procedure of joining the FM WORLD Club

### Stages:

1. Filling out an application form on the website [tr.fmworld.com](http://tr.fmworld.com) – submitting an offer for the conclusion of agreement;
2. Confirmation of receiving the offer by FM World Türkiye by sending an email to the email address provided on the form along with the activation link;
3. Clicking the activation link (the moment of concluding the agreement for participation in the FM WORLD Club);
4. Receiving from FM World Türkiye login ID and a single-use password, and confirmation of concluding the agreement.



## Technical actions composing the conclusion of the agreement

Candidate fills in the '[Online Registration](#)' section on the <https://tr.fmworld.com/> website and submits an offer for the conclusion of the agreement for participation in FM WORLD Club, and as a result, an activation link is sent to the Candidate's e-mail address by FM Word Türkiye. When the candidate clicks on the activation link sent to the -mail address, a contract is deemed to have been established between FMWORLD Club and the candidate in accordance with [FM WORLD Club Rules, Marketing Plan](#) as well as other documents regulating the Business Partner's participation in the FM World Club. Clicking on the link sent by FM World Türkiye confirms that the Candidate has completed the registration form in the '[Online Registration](#)' section of the <https://tr.fmworld.com/> website. FM World Türkiye will confirm the signing of the agreement by sending a final email confirmation along with the Login ID and a single-use password.

The correction of data will occur upon previous verification of the person applying for this correction. The form by means of which the details are submitted, is protected by SSL protocol. The data included in the form are encrypted.
